Shoe noisy during operation

CORRECTION:

Brought unit up to the shop. Got a 2nd person and engaged thresher. Inspected for where the noise was coming from. Went under the unit and found a crack on the leveling frame in front of the fan housing. Dropped pick-up header of along north fence and brought unit into the shop. Made parts and labor quote. Customer came in and we discussed the repair, he gave the go ahead to repair and order the parts. Removed chopper shields, brackets and removed chopper housing from unit. Removed top sieve, bottom sieve and pre-sieve. Disassembled fan drive sheave and removed fan belt. Found wear on the outer pulley, quoted to repair at machine shop. Removed fan and housing from unit. Disconnected grain pan from upper shoe frame and supported pan out of the way. Removed LH and RH eccentric arms. RH bearing was loose in the arm. Disconnected electrical, removed upper and lower shoe frames. Set them on a pallet and moved them outside. Split clean grain elevator chain open. Removed auger bearings and moved the auger to the left in the trough. Removed trough extension shields to elevator. Separated tailings auger housings from auger trough. Supported LH shield and disassembled LH step. Removed auger trough from unit. Supported leveling frame and removed front pin and rear bearing. Lowered frame down and pulled it out. New frame took a while to get here. Once new frame was here, inspected and made sure it was right. Removed eccentric shaft from the old frame and
